Hong Kong Athletes Fund Education Grant

Application Guidelines 2025/26

Introduction

To commemorate the achievements of Hong Kong athletes in the 1996 Olympic and Paralympic Games, the Government established the Hong Kong Athletes Fund ("HKAF"), aiming to provide grants for educational and other academic training to individual athletes to allow them to pursue excellence in their chosen sports and to provide them with the opportunity to develop alternative careers upon retirement from sports. The details of the HKAF are detailed in the following paragraphs.

Eligibility

To be eligible for support, athlete must satisfy all the following criteria:

- Senior current or retired elite athlete of a recognised National Sports Association (NSA); and
- Has achieved <u>Elite Vote (EV) Point 3 or above</u> according to the EV Scoring Table (i.e. medallist (>9 entries) or top 1/3 (≤9 entries) in National Senior Championships, or equivalent or above). Results of junior championships will not be considered; and
- Eligible to represent Hong Kong in competitions that are sanctioned by the respective international federation either before or at the time of the deadline for applications; and
- Has resided in Hong Kong for a minimum of three years and is a holder of Hong Kong Identity Card.

Points to Note for Full-time Training Requirement

Full-time training requirement should be benchmarked with the full-time training athletes as stipulated by the Hong Kong Sports Institute as follows:

a) Athletes have to follow the elite training and competition requirements as their first priority;

d) Athletes taking up part-time job/studies must be approved by Head Coaches/NSAs.

b) Athletes do not have full-time job nor engage in full-time study programmes, except where temporary deferment of the full-time study programme has been approved by the school, or arrangements have been made by the school to reduce the contact hours to the equivalent of a normal part-time programme (i.e. not more than 10 hours per week on average). Documentation issued by the school/employer is required under these circumstances;

c) A minimum of 5 days and 25 hours (for able-bodied athletes) or 5 days and 20 hours (for disabled athletes) of supervised training per week;

If an athlete had ever been employed by the HKSI as a training partner, the serving years as a training partner will not be considered as eligible full-time training in accordance with criteria of this Scheme.

The NSA concerned should be a member association under the Sports Federation & Olympic Committee of Hong Kong China (SF&OC).

Important Notes for Applicants

Please read carefully the following important notes for HKAF applicants:

Eligible Study Programmes/Courses

- 1. Applicants are required to submit their application prior to commencement of the study year/course.
- Courses/modules that have already commenced or completed before the application deadline are not be eligible for education grant.
- Applicants who have received financial support from other organisations/institutions to cover the tuition fee of the applied course in full, these courses are not eligible for education grant, for example, grants and loans are received from the Student Finance Office, University Sports Subsidy Scheme and the Local Education Allowance from the HKSAR Government etc.
- 4. If applicants whose programmes/courses have already been <u>partially</u> subsidised by other funding sources, they can only submit application for remaining courses that have not commenced and are not subsidised.

Collection of Personal Data for HKAF Application

- 5. The personal data provided by means of this application form will be used by the HKSI or other relevant organisations, such as the Student Financial Assistance Agency, for the purpose of verification and processing of applications only.
- 6. Subject to exemptions under the Personal Data (Privacy) Ordinance, applicants have the right of access and correction with respect to his/her personal data.

Acceptance of Applications

7. The HKSI reserves the right to accept or reject any application.

Prevention of Double Benefits of Subsidy

- 8. It should be noted that to prevent double benefit of subsidy, the provision of education grant is to subsidise the study programmes/courses on the basis that the study programmes/courses under the HKAF application have not been subsidised by any other education grant/scholarship/subsidy.
- 9. If applicant has received other education grants/scholarships/funding to support his/her study programme, applicant needs to declare at the time of application/during the study period (if any) and provide supporting information. The education grant (if approved) may be adjusted according to other scholarship/subsidy received.

Reimbursement of Tuition Fees

- 10. Reimbursement of the approved HKAF education grant is based on (i) courses/modules with a passing grade and (ii) actual tuition fees paid by the recipients, as reflected in the official receipts submitted. Applicants must provide supporting documents of these other subsidies for application and approval.
- 11. In the event that applicant fails to complete some courses/modules, reimbursement of tuition fees will be calculated according to established pro-rata mechanism.
- 12. Approved HKAF education grant will be reimbursed by instalments twice a year upon receipt of official tuition fee receipt and proof of satisfactory completion of the previous term of study.

Termination of Education Grant

13. Education grant will be subject to termination or requested for refund of disbursed grant if the successful HKAF recipient withdraws from study/has breached the double benefit principle/provided false/forged documents/information for application.

Grant Approval

14. Successful applicants will be required to accept the terms and conditions of the approved Education Grant.

Application Procedure

- Applications are invited twice a year (around July and December).
- Applicants have to submit the completed application form (<u>download application form</u> from the HKSI website) together with supporting documents to the Athlete Affairs Department of the HKSI by the specified deadline.
- For applicants who are retired athletes, applications must be submitted within two years from the Official Retirement Date.
- Applications received within two weeks after the deadline may be considered, provided that the applicant submits a letter of justification.
- 5. Applications will be presented to the Elite Training and Athletes Affairs Committee of the HKSI for approval.
- 6. All applicants will be informed of the application results in October and March.

香港運動員基金 教育資助 申請指引 2025/26

簡介

為表揚香港運動員於 1996 年奧運及殘奧運的驕人成就,香港政府成立了香港運動員基金(以下簡稱「基金」),宗旨是提供獎學金,支持運動員在教育及學術進修上,讓他們追求運動卓越的同時,也提供機會讓他們在退役後發展個人事業。基金的詳情在下面的段落中闡述。

申請資格

申請基金的運動員,必須符合以下條件:

- 1. 為認可的體育總會(總會)之現役成年或退役精英運動員;及
- 2. 根據精英資助評分表,**達到評分 3 分或以上**的成績(即在全國成年錦標賽取得獎牌(>9 隊)或排名前 3 分之 1 (≤9 隊),或同級或更高的成績)。青少年組賽事成績不會獲考慮;及
- 3. 在截止申請前,符合代表香港參與國際體育總會所認可之比賽資格;及
- 必須居港至少3年,並須在申請時持有有效的香港身份證。

全職訓練定義及要求的注意事項:

- 全職訓練要求應參照香港體育學院所規定的全職訓練運動員:
 - a) 運動員必須以精英培訓及比賽作為其首要目標;
 - b) 運動員並沒有擔任全職工作及修讀全日制課程〔除非得到校方批准暫停修讀全日制課程或修讀時數減至與兼讀制課程時數相同(即每週平均不多於 10 個上課小時)〕,在此情況下必須出示由校方/僱主提供的證明文件;
 - c) 在教練安排下每週訓練時間不少於5天及25小時(適用於健全運動員)或5天及20小時(適用於殘疾人運動員);
 - d) 如運動員欲擔任兼職工作或修讀兼讀制課程,必須獲得有關總教練/體育總會核准。
- 2 如運動員曾在體院受聘為陪練員,期間的服務年數不會被視為符合此計劃申請資格的全職訓練年期。

申請人應該注意的重要事項

申請人在提交申請前,請細心閱讀以下重要事項:

合資格課程

- 1. 申請者須於課程/學年開始前提交申請。
- 如在申請截止日期前已開始/完成的學期/課程將不符合教育資助的申請資格。
- 3. 申請的課程如已獲其他機構提供全數學費資助 (如學生資助辦事處所提供的助學金及貸款、大學提供的運動 員學費資助計劃及政府提供的本地教育津貼等),該課程的學費將不符合教育資助的申請資格。
- 4. 如申請人的課程學費已獲其他機構提供**部份資助**,申請人只可以向基金申請餘下未獲其他資助的課程。

個人資料收集

- 5. 此申請表格內所填寫的個人資料,只會作為香港體育學院及其他相關機構(如學生資助辦事處)審核及處理 申請用途。
- 6. 除個人資料(私隱)條例訂明的豁免外,申請者有權查閱和修改其個人資料。

申請接納

7. 香港體育學院保留接受或拒絕任何申請的權利。

防止雙重資助

- 8. 為防止/避免雙重資助,香港運動員基金的教育資助是基於以申請資助的課程並沒有獲得其他助學金/獎學金/資助支援的前提下而提供。
- 9. 申請人如獲得其他機構的其他助學金/獎學金/資助以支持其學習計劃,申請人需要在申請時/學習期間(如有)申報及提供資料。教育資助(如獲批)可能會因應獲得的其他獎學金/資助而進行調整。

學費發還

- 10. 教育資助下的學費發還是根據 (i) 合格的課程/科目及 (ii) 正式學費收據,就學費收據上申請人所繳交的實際學費。申請人必須提供相關證明文件以供審批。
- 如某學期的成績有不合格的課程/科目,該期學費將按既定比例機制發還。
- 12. 獲批教育資助的申請人需於每年兩次的資助發還期內遞交學費收據及成功修畢該學期的成績證明。

資助終止

13. 如申請人在獲批教育資助後退學/違反雙重資助原則/提供虛假文件/資料,教育資助將會立即終止發放/ 要求退回已發放的資助。

成功申請

14. 成功申請人將需要接受此教育資助既定的條款和條件。

申請手續

- 1. 每年約於7月和12月兩個週期接受申請。
- 2. 於截止申請日期前,將填妥的申請表格(於香港體育學院網頁<u>下載申請表格</u>)與有關證明文件一併遞交至香港體育學院運動員事務部。
- 3. 申請人如為已退役運動員,必須在正式退役日期起計2年內遞交申請。
- 4. 於截止日期後兩星期內所提交之申請可獲酌情處理,惟申請人必須提供相關的說明文件。
- 所有申請將呈交香港體育學院精英培訓及運動員事務委員會檢閱及批核。
- 6. 申請者將會於10月及3月獲通知審批結果。
